A Poll of Florida's Fourth Judicial Circuit Likely Republican Primary Voters Shows Melissa Nelson with a Commanding Lead in the State Attorney's Race

Jacksonville, Fla. – A new poll of likely Republican Primary voters in Florida's Fourth Judicial Circuit by the Public Opinion Research Laboratory (PORL) at the University of North Florida, in partnership with The Florida Times-Union, shows that Melissa Nelson leads Angela Corey in the State Attorney's race 52 percent to 20 percent, respectively. Wes White garnered 7 percent with 21 percent still undecided.

This is a substantial change from the poll PORL conducted at the end of June in which Nelson had 34 percent and Corey had 24 percent. "The increase in support for Nelson is likely a combination of effects from endorsements, positive exposure and a well-run campaign," said Dr. Michael Binder, PORL faculty director. While support for Wes White remained constant since the PORL's poll last month, the undecided voters appear to be gravitating toward Nelson as the August 30th Election Day draws closer.

"Nelson has widespread support across all three counties" said Dr. Binder. "The lead Nelson has opened in the last month is very surprising. Incumbents are typically tough to beat, especially ones with name recognition."

Early voting has been in progress since August 15 and 13 percent of the sample indicated they had already voted. Of those who have already cast their ballot, 57 percent said they selected Nelson and 26 percent said they had voted for Corey.

Florida's Fourth Judicial Circuit likely Republican Primary poll shows that Charles Cofer is ahead in the Public Defender's race.

Jacksonville, Fla. – A new poll of likely Republican Primary voters in Florida's Fourth Judicial Circuit by the Public Opinion Research Laboratory (PORL) at the University of North Florida, in partnership with The Florida Times-Union, shows that Charles Cofer, with 43 percent, holds a comfortable edge over Matt Shirk, with 21 percent, in the Public Defender's race.

"Even though Cofer is ahead by twenty plus points, here is still a great deal of indecision in the electorate for this race", said Binder. "This race has not attracted the same level of attention that the state attorney's race has gotten and, as such, has been overshadowed."

According to Dr. Binder, "Among those who have already cast a ballot, Cofer's lead jumps to over thirty points. But for those who have not yet voted, the lead is less, only twenty points. It is possible that voters who were previously unsure are making the choice to vote for Cofer."

Methodology

The Florida Fourth Judicial Circuit Poll was conducted by the Public Opinion Research Laboratory (PORL), in partnership with The Florida Times-Union, Saturday August 20 through Tuesday, August 23, 2016 by telephone with live callers. Respondents were likely Republican primary voters in the Fourth Judicial Circuit (Duval, Clay and Nassau Counties, Florida). Samples were created through voter files provided by each county's supervisor of elections and selected through the use of randomization among likely voters. Calls were conducted only in English, with 604 registered likely voters 18 years of age or older. Likely voters were considered people who had voted in the 2012 or the 2014 statewide primary election; or were newly registered voters that voted in the 2016 presidential preference primary; or new voters registered after June 27, 2016 were also included as likely voters. In addition to be considered a likely voter, respondent indicated that they would "Definitely Vote" or "Probably Vote" in August's primary election.

The margin of error is +/- 3.99 percent for the survey. The breakdown of completed responses on a landline phone to a cell phone was 43 to 57 percent with <1 percent unknown. The sample used quotas for each county to ensure geographic representation. This survey was sponsored by The Florida Times-Union and the PORL at the University of North Florida and was directed by associate professor of Political Science Dr. Michael Binder. The PORL is a full-service survey research facility that provides tailored research to fulfill each client's individual needs from political, economic, social and cultural projects. The PORL opened in 2001 and is an independent, non-partisan center and a charter member of the American Association for Public
